



**FASHIONOPOLIS WEEK
INVISION DISTINCTIVE EYEWEAR
COMPLETE EYEWEAR PACKAGE GIVEAWAY - OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

ELIGIBILITY: Only legal residents of the 50 United States (including the District of Columbia), who are 18 years of age or older at the time of entry are eligible to enter the InVision Distinctive Eyewear - FASHIONOPOLIS contest (the "Giveaway"). Void where prohibited and subject to all applicable laws and regulations. Entries are limited to individuals only; commercial enterprises or business entities are not eligible. Proof of submission of an entry does not constitute proof of receipt by the Sponsor.

TIMING/ENTRY LIMITS: The Giveaway begins at 12:00 a.m. Central Time ("CT") on Monday, October 5, 2020, and ends at 11:59 p.m. CT on Sunday, October 11, 2020, (the "Promotion Period"). **Limit one (1) entry per person during the Promotion Period.** Any person attempting to submit multiple entries that exceed the entry limit will be ineligible to participate or to receive a prize. Sponsor's computer clock is the official timekeeper for the Giveaway.
